EQ Credit 3.1 and 3.2 Construction IAQ Management Plan (1-2 Points):

CertainTeed GlasRoc Sheathing and GlasRoc Sheathing Type X Products have a Mold Resistant Rating of 10 (maximum resistance) tested in accordance with ASTM D 3273/D 3274. GlasRoc products are manufactured from EGRG (Embedded Glass Reinforced Gypsum) Technology with reinforcing glass mats fully-embedded into a water-resistant gypsum core and a paperless polymer-modified gypsum surface with an acrylic coating on the exterior face.

ID Credit 1 – 1.4: Innovation in Design (1-4 Points):

CertainTeed GlasRoc Sheathing and GlasRoc Sheathing Type X Products are inherently moisture and mold resistant and may qualify for LEED Innovation in Design Credit as they do not contribute to mold growth related to Indoor Air Quality (IAQ).
